PAYMENT & REGISTRATION TERMS All payments are due on or before the start of the event/session.

Late payments are allowed at NET 30 days from the start of the session with a fee of \$35 per person. After 30 days, if payment is not received, interest shall be compounded monthly at 5%. Late Payments are defined as payments made after the start of the event/session.
